

## **Release and Acknowledgement of Risks**

I \_\_\_\_\_ as lessee (customer) understand and acknowledge that the activity to be engaged in through my rental of an inflatable, interactive amusement device, and/or any other item being rented, brings with it the both known and unanticipated risks to myself, my guest, and to my invites. Those risks include, but are not limited to:

- \* falling, slipping, crashing, colliding that could result in injuries, illness disease, emotional distress, death and/or property damage to myself and/or my guest and invites.
- \* failure to follow safety guidelines
- \* Electrical failure resulting in deflation of the unit
- \* Improper installation of inflatable devices
- \* Inclement Weather, Lightning, high wind conditions, rain, or low temperatures

### **Release**

I voluntarily release indemnify, hold harmless and discharge Kangaroo Hop DBA its principals, directors, officers, agents, employees, and volunteers from any and all liability, claims, demand actions, or right of action whether personal to me or to a third party which are related to arise out of or are in any way connected with any rental of the units (Inflatables) including those allegedly attributable to negligent acts or omissions. I also agree to reimburse any attorney fees and costs which may be incurred by Kangaroo Hop, DBA in the defense of any such liability claim, demand actions or right of action.

### **Homeowners', Tenant, or other liability insurance**

I acknowledge that I have adequate homeowners' insurance, tenant insurance, or other liability insurance to cover any bodily injury or property damage which might occur to myself, my guests, or my invitees from the use of the unit I am renting or else I agree to bear the costs of such injury or damage myself.

### **Assumption of Risk and Responsibilities**

I agree to have an adult supervise both the equipment and its use at all times while equipment is in my (customer) possession. A set of rules and directions are displayed in front of the unit and the driver will also explain the safety rules which I agree to follow and utilize at all times during the use of the unit (inflatable) and/or equipment. I understand that I am solely responsible for the correct and safe operation of this equipment as there is no operator left with the unit. Persons renting the unit must provide a clear path to where the unit (bouncer) will be set up or Kangaroo Hop, DBA reserves the right to cancel delivery. The equipment shall not be removed from the original location of set up. I am responsible for all the equipment until the driver picks it up.

The equipment has been inspected before delivery and is in working order. I will inspect the equipment with driver to see for themselves that it is in working order. By signing at the bottom, I am satisfied with the equipment and except it for the duration of the rental agreement. Problems do arise at times and if there is any problem the I (the customer) will contact the office so someone can be sent out to repair or take care of the problem.

### **Weather Policy**

During severe weather conditions such as rain or high winds and/or snowing before your party Kangaroo Hop, DBA reserves the right to cancel any reservation. Under questionable weather conditions, you will be given an option of having your jumper set up. Once the jumper is set up, there will be no refunds and if rain or winds persist, we may pick up the jumper immediately. We will inform you of this policy over the phone, in person and/or in writing if there is a chance of bad weather in the forecast.

### **Entire Agreement**

I acknowledge and certify that I have had sufficient opportunity to read the entire document, and understand its content, and agree to it by its terms. I further warrant and represent that I am either the customer named below or I am authorized and empowered to accept delivery of the equipment and to sign this agreement on their behalf. I agree that I am also binding myself personally as an additional party to all of the terms and conditions of this agreement. No minor can sign. Person signing must be over 18 years of age and I.D. must be available for driver to see. If no I.D. is available, driver will not deliver the unit (inflatable).

**Checklist to review with Customer after set-up:**

- I have been shown how inflatable is secured.
- I have been shown how to turn on/off blower.
- In the event of high winds or storms, I have been instructed to get all participants off the unit and unplug the motor and extension cord from the power outlet. The maximum winds that this unit will allow is up to and not over stated above mph per stated written instructions listed on the unit itself.
- I have been instructed to not allow any horseplay, flips, wrestling or any other unsafe activities both in and around inflatable.
- I have been advised of the following...
  - No shoes or sharp objects in or around the inflatable unit(s);
  - No food, drinks, gum, or silly string in or around the inflatable unit(s);
  - No eyeglasses or jewelry in or around the inflatable unit(s);
  - No pets in or around the inflatable unit(s).
- The SILLY STRING POLICY: Silly String is like super glue when applied to inflatables. It almost does not come off. Our Silly String policy is simple. If we have to clean Silly String off of the inflatable there will be a \$75.00 charge. Silly String cleaning is actually a medium repair expense to an inflatable.
- I understand that adult (18 years old & up) operators must be provided to watch the games at all times.
- I have been advised that children of the same size or age group only may use the unit(s) at any given time.
- I agree to remove any person from the inflatable who is violating posted rules of operation.
- I have received both written and verbal instruction on the safe operation of inflatable and agree to follow all safety rules.

**Driver Set-Up Check List**

**(To be completed and signed each setup)**

- Structure viewed for holes, tears, rips, and seam separation.
- Blower making sure the plug has all three prongs, no tears or separations on chord, and making sure it is securely connected to the unit.
- Electric again making sure that the plug on the blower chord and or extension chord is not reduced by an adaptor to a two prong plug at any time.
- Double checking the tie downs that they are securely holding the unit in place.
- Mats are secured to the ground by stakes or Sand Bags
- Double checking that the unit is clean and in good working condition.
